## **2025 PROPERTY TAXES**

**1<sup>st</sup> Installment or Full Tax Payments, due January 31<sup>st</sup>, 2026, collected by and payable to Town of Green Lake.**

**MAIL:** Check, cashier check or money order payable to Town of Green Lake, Attn: Taxes, N4454 Horner Rd, Ripon, WI 54971. If you would like a receipt, include a self-addressed stamped envelope with your payment.

**IN PERSON:** In person tax collection will take place at the Town of Green Lake Town Hall, N4454 Horner Road on Saturday, December 20th, 2025, from 8:00 AM – 11:00 AM or Saturday, January 17th, 2026, from 8:00 AM – 11:00 AM. Check, cash, money order, cashier check, and credit cards are accepted when paying in person.

**ONLINE:** Debit and Credit Card payments are accepted both online and in-person, a surcharge will be applied. You can access the online payment portal via <https://www.townofgreenlake.gov/>

## **ROOM TAX ORDINANCE**

Effective January 2025 the Town of Green Lake implemented Ordinance 01-2024, which was created under the authority of Wis. Stats. 66.0615, allowing the collection of room tax in the Town of Green Lake.

Room Tax Applications, along with the \$300.00 annual fee, are **due to the Town of Green Lake by March 31, 2026**. You must register with your short-term rental agency by January 1, 2026. Failure to comply may result in a fine. You can access the Room Tax Ordinance along with the Room Tax Permit Application on our website.

*All dogs, over five months, are required to be licensed and vaccinated for rabies by March 31 of each year. Failure to obtain a license from the Town of Green Lake is subject to a \$150.00, per dog, fine from the Green Lake County Sheriff's Department.*
