Town of Green Lake Regular Town Board Meeting Tuesday, April 15, 2025

Notice for this meeting was given by posting at the Town Hall and the Town's website.

Chairman Moderow called the regular town meeting to order at 6:12 PM. Clerk Mehn was absent, and Treasurer Machkovich will be taking the minutes. There were 7 citizens in attendance.

The motion was made by Strelow/Berndt to approve the agenda. Motion carried.

The motion was made by Berndt/Strelow to approve the minutes from the regular monthly meeting on Monday, March 10, 2025. Motion carried.

Motion was made by Moderow/Berndt to approve the vouchers/bills. Motion carried.

Treasurer's Report – Treasurer Machkovich's report was reviewed March total general checking credits were \$24,969.95 and the total general checking debits were \$39,354.97. A motion was made by Berndt/Strelow to accept the report and with the transfer if needed. Motion carried.

Maintenance Report

Dan was absent, Moderow presented the report. Sandstone and Twin Lakes Road was brushed, a few remaining logs and pieces need to be cleaned up. Septic was pumped at Town Hall and Kearley Landing on April 8, 2025. Weight Limit signs have been removed for the season. Salt shed inspection took place, passed inspection. Posts have been placed on Horners Road for the 35 MPH speed limit signs, waiting on decision for 45 MPH speed limit signs before ordering. The piers for Little Green Lake are ready and pending weather for install. Cemeteries have been rolled.

Kathy Grahn & Amanda Castleberry - Green Lake Playground

Amanda and Kathy from "Playground Pals" presented their plan to create an all-inclusive, handicap accessible playground at the current Playground Park in the City of Green Lake. They are trying to raise \$640,000.00 for equipment, benches, shades and ground covering/surface in addition to funds for future maintenance and a 10 year surface replacement. \$350,000.00 has been raised in approximately one year. They are present tonight to ask for a financial contribution to the future park and asked that we put a link to their website and donation page on the Town of Green Lake website. Moderow would like this placed on the May agenda, in the meantime we will place their website and donation information on the Town of Green Lake website.

Tami Schattschneider, Chairperson of Little Green Rehab - Wake boats on Little Green Lake

Tami is here to request the Town pass a wake boat ordinance on Little Green Lake due to the damage they make to the aquatic life, fish habitats and the danger of them to other boaters, kayakers, swimmers and paddle boarders. A majority of their district is in support of this and they have partnered with a coalition to try to align and pull resources against wake boats. The condition report presented includes Spring Lake, Twin Lake, and Little Green Lake along with a draft ordinance. Berndt expressed his concern with the DNR authority and enforcement. Tami mentioned by placing signage and passing the ordinance it should be "self enforcing". Tami asked that advisory signs can be placed while the ordinance is in review, all in agreement that advisory signage can be placed. Little Green Lake will place their advisory signs, The Town of Green Lake will place signs at Spring and Twin Lakes. Tami will send the Clerk the necessary paperwork and instructions if we choose to start the ordinance process.

Horner Road Speed Limit
