Regular Town Board Meeting
Monday, August 12, 2024**

Notice for this meeting was given by posting at the Town Hall and the Town's website.

Chairman Moderow called the regular town meeting to order at 7:00 PM. All board members were absent. There were 7 citizens in attendance.

The motion was made by Berndt/Strelow to approve the agenda. Motion carried.

The motion was made by Berndt/Strelow to approve the minutes from the regular monthly meeting on Monday, July 8, 2024. Motion carried.

Motion was made by Strelow/Berndt to approve the vouchers/bills. Motion carried.

Treasurer's Report – Treasurer Machkovich's report was reviewed July credits were \$68,396.20 – fire dues came in this month and went to Grand River Fire District and debits were \$94,198.04. A motion was made by Berndt/Strelow to accept the report, and the transfer needed. Motion carried.

Maintenance Report – Dan reported crack filled Circle Drive and I ordered stop signs at Horners. Painting parking area lines and center line on Park Road. The boys removed the building at Prairie Cemetery and trimmed the guard rails. The fish trap has been put in. The broom is in good working condition now. Steve has done some shouldering too.

Approval of Temporary License – Avrom Farm – The board did not have to approve anything because the event had already taken place.

Room Tax discussion – Mark Wilton from Green Lake Chamber came to discuss how Forti Bank has agreed to be the administrator of collecting and distributing our room tax. Clerk Mehn will contact Justin Sondalle to get a Room Tax Ordinance drafted up.

Tuleta Hill Road access lot – Clerk Mehn will contact Patricia Bond or Progressive Appraisal OR Matt Greget of Real Estate Appraisal to get an appraisal done to assist in setting a purchase price of the property.

New Assessor – Clerk Mehn will get more quotes from other assessors. We have received one already from Borree Appraisal Services.

Cemetery – The cemetery across the street would like to have the Town of Green Lake take over the cemetery as soon as possible. Clerk Mehn will contact Attorney Sondalle to get a letter report and warranty deed completed. The town will also get any monies left with the association.

T-TECH online tax payment – Lindsey reported that property owners would be able to pay their taxes online. There is a fee of \$99.00 annual fee. A motion made by Moderow/Berndt to sign up with T-Tech. Motion carried.
