

Town of Green Lake
Regular Town Board Meeting
Monday, January 8, 2024

Notice for this meeting was given by posting at the Town Hall and the Town's website.

Chariman Moderow called the regular town meeting to order at 7:00 PM. All board members were present. There were 4 citizens in attendance.

The motion was made by Berndt/Strelow to approve the agenda. Motion carried.

Todd Morris and County Supervisor Bob Schweder came to discuss the wakeboarding boats on Big Green Lake. The damage they could be doing to the lake/shoreline. There is no state law against these boats. The county is hoping to get an ordinance from the four townships and the City of Green Lake to get these boats regulated on Big Green Lake. The ordinance will need to go to the DNR for 6 days prior to reinforcement.

The motion was made by Berndt/Strelow to approve the minutes from regular monthly meeting on December 11, 2023. Motion carried.

Motion was made by Strelow/ Berndt to approve the vouchers/bills. Motion carried.

Treasurer's Report – Treasurer Machkovich's report was reviewed. A motion was made by Berndt/Strelow to approve Treasurer's report.

Maintenance Report – Dan submitted a written report. "Trees have been removed from Welks future parking lot. The dead tree was cut on Sandstone (W1714) as were all but one dead tree removed from Horner's Landing. The brush was cut and chipped on the dead end of LGL road and Miller Road just west of County Road A. Two large cottonwood trees that are down are dying will be removed by Kearly Road just north of the boat landing. Met with Lukasz to go over the boat landing and talk grants. He was going to come up with a plan for the parking on Welks also. The west chain linked fence on Horner's was removed as it was falling apart. The temp sensor was replaced on the chipper and the grader head lights were upgraded to brighter LEDs, as well as going through the plow trucks. Finally, the AED was installed in the Town Hall. 99 plow truck may need replacement frame splitting cracks.

City of Markesan – Recycling Agreement – Clerk Mehn emailed Betsy at the City of Markesan and she noted that the City of Markesan is still working on it. They made a couple changes at the January 2nd meeting, but the Mayor is sending it back to the committee in February. The board will discuss at a later date.

Ordinance 1-2024 NSF Fee – The board made a motion to approve this ordinance. Motion was made by Berndt/Strelow. Motion carried.

Room Tax Ordinance – After discussion, the board made a motion to not do a room tax for the township. Motion made by Strelow/Berndt. Motion carried.

Little Green Lake Landing Fees – After discussion, the board made a motion to not share any landing donations to the Little Green Lake District starting January 1, 2024. Motion made by Berndt/Strelow. Motion carried.
