

**Town of Green Lake**  
**Regular Town Board Meeting**  
**Monday, January 12, 2026**

Notice for this meeting was given by posting at the Town Hall and the Town's website.

Chairman Moderow called the regular town meeting to order at 7:00 PM. All board members were present. There were 3 citizens in attendance.

The motion was made by Berndt, seconded by Strelow to approve the agenda. Motion carried.

The motion was made by Strelow, seconded by Berndt to approve the minutes of the regular monthly meeting on December 8, 2025. Motion carried.

Motion was made by Berndt, seconded by Strelow to approve the vouchers/bills. Motion carried.

**Treasurer's Report** – December report was reviewed by Treasurer Machkovich, \$2,424,929.89 in credits and \$46,143.28 debits. Reported balances on Money Market, CD and Phelps Savings Account. Motion to approve Treasurer's report and the transfer needed as presented by Berndt, seconded by Strelow. Motion carried.

**Maintenance Report** – Dan reported they have weighed the trucks empty and full of salt to keep better track of our salt usage. Currently they have plenty of salt as many others are running out. In February Dan plans to get the county boom truck to limb trees. This next week we'll cut low hanging brush. The loose gravel signs borrowed from the county have been returned. The steering assist box was replaced on the 1999 truck. The truck is currently being assessed for frame replacement. Tire chain cross links have been changed on the grader. More have been ordered. On January 16<sup>th</sup> Dan and Austin will be going to the MSHA training. The boat launch enveloped for the 2026 season is done and were picked up today. The septic tank has been marked with a traffic cone along with the drain vent. Dan asked if there were charges from the town to mark cemetery lots.

**Conditional Use Permit application** - Lakeview Inn Land LLC – The board approved the CUP application from the Lakeview Inn Land LLC for the current bar, restaurant and apartment rental operation, as well as to add boat slips for rent. The motion was made by Moderow, seconded by Strelow to approve the application. Motion carried.

**Plow truck** – The plow truck had an incident this month. Dan took some pictures and sent them to Quality Truck. They are getting a quote together. They think the frame is twisted and could possibly cost 30K to fix. Ripon Truck Repair has a truck they have to use in the mean time while this truck is out. They would lease it out, just not sure what the price could be. A motion was made by Strelow, seconded by Berndt for Ben to ask Ripon Truck Repair if they would allow the town to rent a truck for \$1,000 a month. Motion carried.
