

**Town of Green Lake
Regular Town Board Meeting
Monday, March 10, 2025**

Notice for this meeting was given by posting at the Town Hall and the Town's website.

Supervisor Berndt called the regular town meeting to order at 7:00 PM. Chairman Moderow called in for the meeting via phone due to illness. Supervisor Strelow and Treasurer Machkovich were absent. There was 1 citizen in attendance.

The motion was made by Moderow/Berndt to approve the agenda. Motion carried.

The motion was made by Berndt/Moderow to approve the minutes from the regular monthly meeting on Monday, February 10, 2025. Motion carried.

Motion was made by Moderow/Berndt to approve the vouchers/bills. Motion carried.

Treasurer's Report – Treasurer Machkovich's report was reviewed February total credits were \$1,293.71 and the total debits were \$3,071,568.45, the February Tax settlement was part of this. Dog license applications are due by March 31, 2025 – tags will be issued the week of March 17, 2025. Tax collection is finished, the tax account is now at \$0.00, all remaining tax collection funds have been transferred to the money market general account. A motion was made by Berndt/Moderow to accept the report and with the transfer if needed. Motion carried.

Maintenance Report – We picked up new plow blades for the two dump trucks as the old ones are wearing through the carbide. There was a dead tree on Kearly that was broken off and leaning against another tree. Steve and I removed that as well as a cottonwood leaning over the bridge on Utley Road. I received a quote from Area Asphalt for the Phelps Cemetery drive. The drive would be widened to 9' and the radius would be widened. No fence will need to be taken down. The trees have been trimmed in the Center Cemetery. Brush pile has been burned a couple times. I will be ordering engine oil from Alcivia on Thursday I'll be picking up cold patch from the county. One March 7th we installed all the 10 ton weight limits signs on all town roads. Just received the salt contract for next year. No pricing until a later date.

Kathy Grahn – Green Lake playground – she will come to our April meeting.

Phelps blacktop – A motion was made by Berndt/Moderow to accept the bid from Area Asphalt Inc. for \$25,600.00. The monies will be coming out of the Phelps Cemetery account. Clerk Mehn will send the signed contract with the 25% deposit of \$6,400.00. Motion carried.

Open Book and Board of Review dates and Training – Clerk Mehn received an email from Ryan at Municipal Group that we will have open book and BOR likely in August/September this year. I have also signed Supervisor Strelow for the Board of Review Training in March.

Annual meeting date – It will be on Tuesday, April 15th @ 6:00 and the regular monthly meeting will follow immediately after.
