

**Town of Green Lake
Regular Town Board Meeting
Monday, May 12, 2025**

Notice for this meeting was given by posting at the Town Hall and the Town's website.

Chairman Moderow called the regular town meeting to order at 7:00 PM. Treasurer Machkovich was absent. There were 5 citizens in attendance.

The motion was made by Berndt/Strelow to approve the agenda. Motion carried.

The motion was made by Strelow/Berndt to approve the minutes from the regular monthly meeting on Monday, April 15, 2025. Motion carried.

Motion was made by Moderow/Berndt to approve the vouchers/bills. Motion carried.

Treasurer's Report – Treasurer Machkovich's report was reviewed April total general checking credits were \$59,906.20 and the total general checking debits were \$52,575.21. We received our Phelps disbursement from Horicon Bank for \$16,057.19 that will be transferred to the Phelps account. A motion was made by Berndt/Strelow to accept the report and with the transfer if needed. Motion carried.

Maintenance Report

Dan was absent, Moderow presented the report. All winter equipment has been removed from the trucks. The piers have been installed on Little Green Lake and Horner's Landing. Trucks have been rinsed but will get a wash/wax soon. The shoulder machine will be mounted this week. The water softener has been replaced in the town hall as well as some leaky valves and piping. Replaced the relief valve on the water heater also. The cemeteries have been mowed and cleaned up. The speed limit signs have been installed on Horner Road and the signs will go up later this week. Ditch mowing will start when the grass gets taller.

Kathy Grahn & Amanda Castleberry – Green Lake Playground

Chairman Moderow suggested that the town does not do a donation since this playground would not be in the township. Motion made by Moderow/Strelow to not do a donation, but we will still put the donation information on the website. Motion carried.

2025 Roads

Lukasz from GEC Engineers came to discuss the road bids for 2025 projects. He suggested paying the retainer the town held from last year's Horner Road project in the amount of \$5,813.59 to Kartechner. GEC received two bids for the Lakewood Estate Road improvement the first one was Kartechner Brothers for \$186,040.89 and the second was Northeast Asphalt for \$222,736.32. The board made a motion to pay the retainer to Kartechner for \$5,813.59 and the bid from Kartechner for \$186,040.89. Motion made by Berndt/Strelow. Motion carried. Chairman Moderow stated that the town could also accept all the bids for chip sealing that were received from Scott Construction. Those were Oakwood Beach Rd \$27,803.00, Circle Dr \$6,394.00, Phelps Rd \$60,969.00. Motion made by Berndt/Moderow. Motion carried.

Cemetery CDs

The board decided to keep these CDs going for the cemetery. At the next meeting the board will discuss the Phelps account and possibly put some of that money into CDs.

Audience Participation

Michele Szkwarko asked about room tax collection and the speed limit on Horner's Road.

Wally Szkwarko just wanted to commend Clerk Mehn and Treasurer Machkovich and all their help.

Bob Strelow asked if the town could change the signs on the boat launch that says truck and trailer parking.
