2024 Budget Hearing/Electors Meeting & Regular Town Board Meeting
Monday, November 6, 2023

Notice for this meeting was given by posting at the Town Hall and the Town's website.

The 2024 budget hearing was called to order at 6:35 p.m. by Supervisor Berndt. Chairman Moderow was absent. There were 5 electors from the Town present. The 2024 budget summary was available for viewing.

Motion was made by Strelow/Berndt to approve the 2023 total town Levy to be collected in 2024 for the Town of Green Lake in the amount of \$ 723,408. Motion was made by Strelow/Berndt to approve the 2024 Town of Green Lake budget & the 2024 Highway budget. Motion carried.

Supervisor Berndt called the regular town meeting to order at 6:48 p.m. All board members were present.

Motion was made by Strelow/Berndt to approve the agenda. Motion carried.

Motion was made by Strelow/Berndt to approve the minutes from the October 2, 2023, regular monthly meeting as printed. Motion carried.

Motion was made by Berndt/Strelow to approve the vouchers/bills. Motion carried.

Treasurer's Report – Treasurer Machkovich's report was reviewed. Boat launch numbers have increased by 25%. The total collection for both Horner's and Little Green Lake landings as of September was \$10,907.16. Dan K. did collect more money for the month of October. Lindsey will get a final amount for the December meeting. Clerk Mehn will cut a check at the December meeting. Dog License fee will stay the same. Motion made by Berndt/ Strelow to approve the report. Motion carried.

Maintenance Report – Dan reported the mowing is done for the year. All that is left is mulching the leaves. The winter equipment is being mounted on the trucks. The hoist ram on the 99' truck was rebuilt as it was starting to leak badly. The piers were removed on the last Friday of October. No parking was painted on the south side of the LGL east parking lot. We have started to remove dead trees and brush

along the road. The trees by the future Welks parking lot will be removed later this month or the beginning of December. on

Approval of Zoning Map Amendment – Motion made by Berndt/Strelow to approval the zoning map amendment from Green Lake County. Motion carried.

Rezone application for Ricky & Ashley Ruck – Ashley Ruck spoke on behalf of what they would like to see happen with their properties. Other residents were at the meeting and spoke not in favor of this rezone. The board objects to and requests denial of request due to the location of the property. The board will also approve the Resolution for the denial. Motion by Moderow/Strelow. Motion carried.

City of Markesan – Recycling Agreement – The board discussed a few items that they didn't like in the agreement. Clerk Mehn will contact Attorney Sondalle to look at this agreement. Will discuss at a later meeting.

Tax Collection/Annual Letter – Treasurer Machkovich went over the letter. All forms will be on the website. Motion made by Moderow/Berndt to approve that letter. Motion carried.
