**Treasurer's Report** – Treasurer Machkovich's report was reviewed October total credits were \$50,653.22 and the total debits were \$44,770.02 you can add \$8.24 and \$1,292.51 of bank interest. Motion made by Berndt/ Strelow to approve the report with the transfer needed to cover the meeting checks. Motion carried.

Maintenance Report – Dan reported they went around and removed concrete wash outs from the ditch. The weed sprayer was winterized and put away. Replaced posts and signs on box culvert on Searle Road north of Miller Road. Filled holes in Phelps and County K cemeteries with dirt and seeded. The Hill Blocks View sign will be installed on Tuleta Hill Road next week. 99 truck was taken to Packer City and had the

differential lock fixed. The truck is back. Horner Road project is almost done. All that needs to be done is dirt by the curbing. A new barrel of DEF was picked up for the flow truck and tractor. In the next couple weeks the winter equipment will be mounted. After deer hunting Egbert will fix up the east landing on Little Green Lake. The piers were removed on November 4<sup>th</sup>.

**Tax Collection/Annual Letter/Room Tax Application** – Treasurer Machkovich went over the letter. Dog license will be kept the same. Lindsey will do in person collection on Saturday, December 21 and January 18 from 8:00 AM until 12:00 PM. June 14, 2025 will be bulk trash day from 7:00 AM until 12:00 PM All forms will be on the website. A room tax letter will be going into with all tax bills. Motion made by Moderow/Berndt to approve that letter. Motion carried.
