

**Town of Green Lake
Regular Town Board Meeting
Monday, October 14, 2024**

Notice for this meeting was given by posting at the Town Hall and the Town's website.

Chairman Moderow called the regular town meeting to order at 7:00 PM. Treasurer Machkovich was absent. There were 9 citizens in attendance.

The motion was made by Berndt/Strelow to approve the agenda. Motion carried.

The motion was made by Strelow/Berndt to approve the minutes from the regular monthly meeting on Monday, September 9, 2024. Motion carried.

Motion was made by Moderow/Berndt to approve the vouchers/bills. Motion carried.

Treasurer's Report – Treasurer Machkovich's report was reviewed September total credits were \$8,931.93 and the total debits were \$26,084.14. A motion was made by Moderow/Berndt to accept the report and a transfer if needed. Motion carried.

Maintenance Report – Dan reported they place 68.59 ton of shot rock under and down stream of the culvert on Oakwood Avenue by the curve. The new culverts on Menominee have been covered by cold mix as there is plans to pave next year. They started cleaning up Oakwood Avenue trees. The dead tree in Phelps Cemtery has been removed and the oak tree by Little Green Lake east landing. The tree leaning over the road on Susan Drive has also been removed. Waiting on the Hess Road sign on Dead End signs as the Hess Road sign was pulled out and taken. A new flag was put up in Phelps Cemtery. The power washer has been repaired and is working good. The first week of November the piers will come out. The day will depend on the weather. Welks pier will be brought back to the shop for repairs. Also around that time one truck will be mounted with winter equipment. The second handicap sign was installed at Horner's Landing. The 99 truck needs to be looked at. Dan will take the truck to Quality Truck or Packer City to get fixed. The board is good with it getting fixed.

Randy Roeper – EMS Service – Randy came to talk about his experience with the county's EMS service.

Tuleta Hill Access lot – After Clerk Mehn spoke with the County Treasurer's office, Register of Deeds and Land Use and Zoning the town would be unable to sell this lot. The plat of survey must have access to lake. A motion made by Moderow/Strelow to void the sale. Motion carried.

Green Lake County Emergency Survey – Chairman Moderow will be completing this survey for the county and will be forwarded back to the county.

Room Tax Ordinance – The board has decided to do the 8%, have signage by the property that it is a rental with name and phone number, permit number. They also want a \$300 annual permit fee. A motion by Strelow/Berndt to accept these items for the room tax ordinance. Motion carried. Clerk Mehn will contact Attorney Sondalle with the changes. This room tax will go in effect January 1, 2025.

2025 Revaluation – Municipal Group would like to do the revaluation this coming year 2025. The board did agree with them doing the revaluation in 2025.

November meeting date – November meeting date will be changed to the first Monday of the month, which would be November 4th at 6:45 start time – for budget and tax purposes.

Budget workshop – Board members just looked at the budget worksheets

Green Lake Cemetery – the board will have the elector meeting on November 4th at 6:30. Clerk Mehn will contact Sondalle Law and the cemetery association about this time.
